INFORMATION PROVIDED BELOW REFERS TO BLOCK NUMBER ON ORIGINAL REPORT AS INDICATED IN LEFT COLUMN.

1. Laura Maroon told her on 06/13/89 that Remi had been having sex with her over a period of 3 years beginning when she was 14 yrs. old. Laura Maroon is presently 30 yrs.

2. Theresa Kasper stated that on or about 06/16/89 she spoke with her daughter Sarah who is presently 18 yrs. of age and that Sarah told her that when she was about 7-8 years old Remi had oral sex with her and that these sexual acts went on for about one year.

3. Kasper stated that she then spoke with her sister Nancy who told her of sexual acts that occurred with Remi. (See Off. Palmer's report).

4. Kasper stated that she knew that Remi Gonzalez was working and counseling young adults at Sacred Heart Church and feared that he was not in a position to give counsel and may in fact be a danger to the children so she went and spoke with Fr. Streng of Sacred Heart R.C. Church. She said that Fr. Streng told her that he was only the spiritual advisor to the youth group and that she should be careful and not tarnish Remi's reputation. She said that Fr. Streng told her that Remi had made admissions that he had done terrible things in the past but that now he was "reborn".

5. Kasper also stated that back in the summer of 1970 Remi came to her home at about 12:00 hrs. and told her that he was having problems with his wife and that they were emotional and sexual problems. She said that he suggested that she assist him with his sexual problems. Kasper stated that Remi attempted to convince her for about an hour before he left the home.

6. Theresa Kasper and Nancy Maroon were advised that because of the statute of limitations that a criminal proceeding could not take place.

7. Mrs. Kasper stated that she felt that the matter should be brought to the attention to the superiors of Fr. Streng and provided a copy of a letter that was addressed to Bishop Edward Head of the R.C. Diocese of Buffalo.

8. Case administratively closed.

Interviewed Nancy G. Magoon dob 6-7-61, 2954 Niagara Road, Niagara Falls, NY, 731-2714. She stated that approximately 15 years ago, when she was from 13-15 years old, Remi Gonzalez, who is her brother in law, sexually abused her on several occasions. She stated that it would happen when she would babysit for Remi, who is married to her sister, Barbara. She stated that most of these occurrences took place at Remi's apartment which was located at the corner of 13th St. and Linwood Avenue, upstairs from his parents. She said that on one occasion she was forcibly raped by Remi at a motel room, and more than once, she was forced to sodomize Remi. Several other times, she was touched on her breasts and vaginal area by Remi. She stated that at the time, she did not disclose this to anyone because she was afraid, and that Remi said it was normal to do this. The last time he abused her was when she was 15 years old, and she began to scream and yell, and Remi's parents downstairs heard the commotion and checked to see if she was OK. Nancy later found out that Remi had also sexually abused her sister Laura, who now lives in Arizona.
